1. Objective:

MegLIFE Project has:

- 1. 11 number of Tally Prime Single User Versions installed in Eleven Districts DPMU offices in Meghalaya.
- 2. 1 number of Tally Prime Multi User Version (Tally Prime 2.1 version GOLD Edition) installed in Head Office – SPMU, at Shillong.
- 3. MegLIFE is looking for a prospective **Tally Partner/ Distributor**, etc who would help in synchronization of all the Tally Data from the District offices and Head office.
- 4. Migration of the existing Tally system to Cloud Tally and integration with existing MIS system of the project.

2. Deliverables:

- 1. Synchronization of the Tally data maintained at 11 DPMU offices and at SPMU office
- 2. Migration to Cloud Tally and integration with existing MIS of the project
- 3. The bidder is required to provide mechanism (preferably an API) to extract the accounting data from Tally in full/incremental mode. It should be possible to interface this with third party systems.
- 4. The bidder is required to furnish a technical design document to explain this whole process.

3. Duration of Assignment:

The assignment should be completed within **ONE WEEK** of issue of the work order.

Terms and Conditions

- 1. **Eligibility:** A Bidder (a) shall not participate in more than one Quotation; (b) shall not have Conflict of interest as defined in the Procurement Regulations and (c) should not have been (i) temporarily suspended or debarred by the State/Central Government/PSU's or (ii) blacklisted or suspended by Central or any State Government Departments in India.

- 3. If the Purchaser receives any request for clarification of this RFQ Document, it will upload its response together with any amendment to this document, on <u>www.mbda.gov.in</u> for information of all Bidders. Bidders should check on the website, for any amendments to the terms and conditions and for Award of Contract.

4. Place of Delivery:

The sealed bids must be submitted on or before the date mentioned at the following address:

5. Quotation Price

- a) The quantity offered should be 100% of the requirement for the quoted amount. Corrections, if any, shall be made by crossing out, initialling, dating and re writing.
- b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- c) Goods and Service Tax (GST) should be indicated separately.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) Bidder must expressly mention the name/brand of the items offered by them in the price schedule along with proper product brochures.
- f) The bidder must mention in details about the product being offered. Bids with no proper details are likely to be disqualified.

6. Qualification of Bidders

- a) Have the legal capacity to enter into a contract;
- b) Not be insolvent, in receivership, bankrupt or being wound up or subject to legal proceedings for any of these circumstances;
- c) Not have had your business activities suspended or debarred from public procurement by the State Government of Meghalaya or Government of India. (Annexure-I)

- 7. **Documents Evidencing Qualification:** Bidders are requested to submit copies of the following documents as evidence of your qualification.
 - a. Valid trading license/registration or equivalent/Exemption Certificate.
 - b. Valid certificate of GST registration;
 - c. CA certified audited financial turnover for the last 3 years.
 - d. Copies of relevant experience certificates (contracts) to be submitted along with bid in support of goods (or service) supplied in the relevant financial years.
 - e. Self-declaration to the effect the bidder is not insolvent, in receivership, bankrupt or being wound up or subject to legal proceedings for any of these circumstances.
 - f. Self-declaration that the bidder's business activities are not suspended or debarred from public procurement by the State Government of Meghalaya, any other State Government or Government of India.
- 8. **Validity of Quotation:** Quotations shall remain valid for a period not less than 60 days after the deadline date specified for submission.
- 9. **Evaluation of Quotations:** The Purchaser will evaluate and compare the proposals that are determined to be substantially responsive i.e., which
 - (a) are properly signed; and
 - (b) Confirm to the terms and conditions and specifications.
 - (c) Any historical information, if required may be asked from the bidders during evaluation of quotes.
- 10. Award of contract: The Purchaser will award the supply orders to the bidders whose quotations have been determined to be substantially responsive and who has offered the lowest evaluated quotation price. The announcement for this assignment will be published in <u>www.mbda.gov.in</u>
 - a. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract. The numbers of item may increase or decrease at the time of issuing the Purchase Order.
 - b. The bidder whose quotation is accepted will be notified of the issue of Supply Order by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order (sample form attached).
- 11. You are requested to provide your sealed quote latest by 1600 hours on 16 December, 2022. Quotations that have been submitted on or before time will be opened at 1630 hours on 16 December, 2022. Late quotes will be rejected.
- 12. Payments shall be released on completion and subject to acceptance of deliverable by the client. However, for any issues experienced post completion and acceptance of the work the purchaser, the vendor should provide support in resolving the technical issues.
